



## ORDINANCE 2012-07 SETTING QUALIFICATION FEES

**WHEREAS**, Section 11-46-2, Code of Alabama authorizes municipalities to adopt ordinances establishing and fixing a qualification fee to be imposed upon all candidates seeking election in municipal elections conducted under the general election provisions.

NOW THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF PERDIDO BEACH, ALABAMA AS FOLLOWS:

**Section 1.** A qualification fee in the amount of (ten) \$10.00 is hereby fixed and imposed upon all candidates seeking election as *mayor* of the Town of Perdido Beach, Alabama, except as hereinafter provided for.

**Section 2.** A qualification fee in the amount of (ten) \$10.00 is hereby fixed and imposed upon all candidates seeking election as *councilmember* of the Town of Perdido Beach, Alabama, except as hereinafter provided for.

**Section 3.** Such qualification fee shall be paid to the city clerk and deposited to the general fund of the city at or prior to the time of taking out qualification papers by any such candidates.

**Section 4.** Any person desiring to qualify who is not financially able to pay the required fee may qualify provided such prospective candidate furnishes the clerk with an affidavit stating that he is financially unable to pay the required fee fixed by this ordinance. \*

**Section 5.** This ordinance is adopted pursuant to Section 11-46-2 of the Alabama Code of 1975 and shall be effective in all elections, both general and special, for aforesaid offices from and after the date of adoption.
