Fire Safety Report-EMS - 3, Structure Fires - 2, Public Assist - 1, Smoke Investigations -1 All vehicles and equipment are in service except for Pickup Truck.

A Medical First Responders Course will be offered starting Monday June 7, at 6:00 PM, Classes will be held on Mondays and Thursdays and will last approximately 7 weeks.

Attorney Stone explained that due to the grant requirements, all items purchased will be owned by the Town but may be used by the PBVFD for this project and in perpetuity. Other Alabama Municipalities, \$2,000,000.00 repaid by the Town of Gulf Shores for "debris removal" where debris was removed, and counties have had to repay grant monies of this type. The Town is responsible for these monies. At some point in the future, if the Town were made to repay grant funds, the materials, equipment, or boat and trailer could be sold to offset the debt. The Town can pay for the Insurance of the vessel. Councilmember Kaiser made a motion to lease the boat, motor and trailer and other equipment to the PBVFD and Councilmember Larsen seconded the motion. No discussion-all in favor motion carried.

Chief Ken Wright agreed to the terms as to ownership of all items purchased with grant funds and will execute the contract prepared by the Town Attorney regarding same.
