Finance & Audit Committee

Beautification Committee

Safety Committee

Chairman Thompson reported that in the event a hurricane brings oil ashore caused from the Oil Disaster, ADEM will be responsible for cleaning up the oil. If the high tides bring oil into residences, ADEM will not enter a residence without the owners being present.

Public Works Committee

Chairman Resmondo reported on signs being vandalized on Riggs, Bohling and Perdido Vista Streets in the Town. Work was being done on the drainage problems at Magnolia and Juniper Streets.

Building Committee

Chairman Kelley reported that the platform in the Conference Room was nearly finished. He presented some ideas for pole barn that could be used for boom storage during the oil crises then be used for other purposes in the future. Recommendation: Building Committee Chairman Kelley to award job of of putting a new roof on Town Hall to Perdido Beach Construction Co. Discussion: Vote-All in favor.
