<u>Public Works Committee</u> Committee Chairman Resmondo reported that a resident had reported erosion at the end of Mobile Avenue and that the eroded portion had been barricaded and that there was also some erosion on Bay Avenue.

He also reported that a 25mph speeding sign had been placed on west Magnolia Street and also that the Public Boat ramp at the end of Magnolia Street had been removed.

ITEM: Chairman Resmondo recommended the Town Council approve a contract with Overstreet Irrigation & Landscaping, Inc. to allow them to provide a "one time" mow in designated rights of way within the Town. Mowing would be provided at an hourly of \$65.00 per hour which includes tractor, driver and bush-hog. Discussion.
