Shelves for storage closet- Now have 3 years of tax records that need to be stored. Lynn says that we have empty closet that could be used if we had shelves. Will ask council to approve money for buying shelving. Sean will install if approved.

Running Toilet- Sean will fix toilet

Solid door for AC Heat unit- AC tech has recommend a solid door for utility closet. Would improve air flow. Sean will install solid piece of plywood on existing door.

Smoke Alarm- Needs to be re-installed in council room- Sean will do

Sean made the suggestions that as part of community newsletter we ask for volunteers with specific expertise to help with small jobs around building and grounds. All work would need to be pre-approved by the mayor. If ok with the council, Priscilla volunteered to write article.
