PERDIDO BEACH VISIONING SESSION SEPTEMBER 27, 2013

MIKE CROWLEY, Institute for Sustainable Communities, provided information on the grant and its purpose.

MIKE CROWLEY interviewed about 25 stakeholders and the following was evident in looking at the interview responses:

- Perdido Beach wants to preserve what they have here. We are a residential community with shared values. We value our private property rights and beautiful waterfronts. We do not want to be what other waterfront communities in South Baldwin County have become.
- There has been a great deal of change needs to be dealt with, such as siltation of the creeks, erosion of the waterfront and increased tourism.
- Everyone seems to share the same core values.
- · There is indication of an element of distrust.

MIKE CROWLEY provided the following recommendations as a result of interviews:

- Do not start with technical solution. However, let's identify the primary shared values. Engage in conversation establishing common goals and initiatives. Surveys, focus groups and town meetings are ways to address.
- Perform some studies determining the causes of erosion and saltation.
- City needs to be clear on rules and regulations and community needs to find out what rules are and how they are being enforced, bearing in mind that property rights is a core value.

BOB GROSS stated the following:

- This needs to be an initiative that is born in the community, not the government or the resilience team. Stagecoach analogy.
- Establish a resilience plan that takes into account the inherent natural risks of the community. Safety and security of your property is the main objective of this visioning session.
- Request for input either verbal or written. Request for communication on all issues whether it relates to resilience or not.

MIKE SHELTON - What does resilience mean to you? Following responses from participants:

- Water quality improvement of soldier's and palmetto creek and the ability to protect it from future damage.
- Finding appropriate water access for town residents; both pedestrian and boat accesses. How can you restrict it to residents only and keep it closed to outsiders?
- Prevention of coastal erosion, specifically loss of land. Shoreline erosion on offsite property is causing loss of private land.
- Definition of the Town of Perdido Beach culture, who are we. Possible development of a Perdido Beach brand. Branding helps in rebuilding following a catastrophic event.
- Sustain our recreational fishing, crabbing and shrimping.
- Safety
- Manufactured home owner needs shelter that is not too far away. If nearby, can get back to her home if shelter is nearby. She wants to be able to get to her home and get back to normal as soon as possible.
- If there is an evacuation, how do we protect ourselves from criminals after a storm event? How do we protect ourselves, homes and properties from people who take advantage of our vulnerabilities following an event?
- Ability to recuperate/come back following a storm event.

- Concern about economic diversification and the ability to create financial security. Explore how
 we can restore our financial security following a storm event. How can we be financially secure
 without losing what we have here now?
- If there is a disaster that destroys my home, I want to build back in a way that has reduced my vulnerability.

MIKE SHELTON - How is Perdido Beach vulnerable? How can resilience be improved? Following responses from participants:

- Concern about inability to return due to destruction of roads and the financial ability of town to rebuild the roads following a storm event.
- Stormwater management. Drainage and roadway infrastructure needs to be managed and maintained by the government, both within and outside corporate limits.
- Erosion issues day to day, in general (wind, tidal action, boat wake)
- Erosion problem along the south shoreline along Bay Drive.
- Controlling development. Does not believe in sea level rise. We have technology now that warns
 us about impending hurricanes. Communities should handle oil spill response Federal
 Government did not handle well. A mobile home should be able to be built next to a mansion.
 Concerned about bulkheads adjacent to natural shorelines. We need to control development
 because there are more people located on the coast.
- COUNCILMAN FISHBEIN. We are responsible for our homes. I am responsible for my own erosion; I am responsible for my property. Compared Perdido Beach to the rainforest; as the world sees it; we are extraordinary and outstanding. We have a special way of life and we are private people. Concerned about public boating and tours coming into our inlets and creeks. I don't want to be told how my home needs to be rebuilt following a storm event. I want to build it back the way I want to build it (the way it was there before). Army corps of Engineers has jurisdiction and allows for jetties with lovely beaches in between the jetties. Marine life teems along bulkheads. Does not believe that sea level rise is an issue and the government is causing fear to support an agenda.
- Preserve options in addressing disaster response and rebuilding (recovery).
- A nonresident property owner would like to see more representation of nonresident property owners and how that can be accomplished. Another nonresident property owner would like to be more involved (in a very positive way) and requests better communication.
- BOB GROSS. Is there a possibility of intra-community communication prior to, during and following a storm event? Intra-citizenry communication. Following responses from participants:
 - Fire Department will be communicating with individuals (including door to door) and there
 is an Emergency Operation Plan already in place. The EOP needs to be communicated
 with the property owners.
 - 2. "Draft blueprint and components"
 - 3. I want to get my communication from the Mayor and City Council. The communication needs to be provided consistently and at one location the city website. I do not want to have to be on an email list in order to get information.
 - 4. Direct communication from the city.
 - 5. Recommends a town bulletin board type of information exchange. (Are there existing websites that provide a bulletin board exchange of information capability?)
 - 6. Communication is a two-way street. Encouraged the attendees to communicate with city hall, specifically stop in and stay in touch. There is a great deal of information available!

Take everything that has been provided today. Verify how and what has been already addressed and provide the information back to the community.

Resiliency team to evaluate input provided in the meeting in order to provide a needs assessment.
