The Baldwin County Commission, during its regularly scheduled meeting held on November 4, 2014, took the following actions:

- 1) Pursuant to the request of the Town of Perdido Beach, Alabama, authorized, with respect to Section 11-102-1 through 11-102-8 of the <u>Code of Alabama</u>, 1975, the adoption of *Resolution #2015-033*, by which the Baldwin County Commission consents for the Baldwin County Planning and Zoning Department to administer the Town of Perdido Beach's Land Use and Zoning Ordinance and Subdivision Regulations, and any amendments thereto, within the corporate limits of the Town of Perdido Beach with the understanding that:

NOW, THEREFORE, the COMMISSION and the MUNICIPALITY do hereby agree, pursuant to all authority under Alabama and/or applicable law, as follows:

claims, demands, notices, violations, findings, actions or orders of whatsoever kind or character which may arise from, or which are in any way related to, the work done and duties or obligations performed by the COMMISSION pursuant to this Agreement, including, without limitation, attorney fees and legal expenses and costs incurred as a result of the County enforcing, defending or complying with this Agreement, or otherwise addressing or defending any actions or claims related in any way to this Agreement. This provision shall survive the expiration or termination of this Agreement.

- This Agreement may be amended or modified only by the written consent and agreement of the parties to this Agreement at the time of such amendment.
- 7. The failure of either party to enforce any provision of this Agreement shall not be construed as a waiver or limitation of that party's right to subsequently enforce every provision of this Agreement.
- 8. This Agreement and the documents referred to in this Agreement constitute the entire agreement between the parties, and there are no other responsibilities, conditions, covenants or agreements which shall be binding upon the parties.
- 9. The parties hereto acknowledge that each party and its counsel have reviewed and revised this

 Agreement and that normal rule of construction to the effect that any ambiguities are to be

 resolved against the drafting party shall not be employed in the interpretation of this Agreement

 or any amendments hereto.

In cases not otherwise directed by law or ordinance, such contracts shall be entered into and executed by the mayor in the name of the city or town and all obligations for the payment of money by the municipality, except for bonds and interest coupons, shall be attested by the clerk. This section shall not be construed to cover purchases for the ordinary needs of the municipality; and

WHEREAS, the Town has sought and received proposals from qualified contractors for the repair of Riggs Street; damage caused as a result of the severe flood event of April 28th and 29th, 2014.

THEREFORE, BE IT RESOLVED, after reviewing the proposals submitted, the Town Council does hereby award contract to Gene's Dozer Service, Inc. for repairs to Riggs Street and does hereby authorize the Mayor to execute necessary documentation.
