Pending Recommendation to the Council:

The Public Works Committee makes the following recommendations to the Town of Perdido Beach Council:

- An impact fee should be established dedicated to Public Works on each new build home in the Town of Perdido Beach. The funds generated are needed to repair damages to the roadways by heavy trucks used in new build projects.
- 2. In as much as Baldwin County is considering repaving Hwy. 97 in FY 2015 / 2016, it is potentially cost effective to add repaving of the portions under town maintenance to the county project. The portion under town maintenance is approximately 1.2 statute miles. A rough estimate for repaving is \$100k per mile. We recommend that the finance committee be directed to develop a plan for how this will be financed in anticipation of this expenditure.
