RESOLUTION 2015-17 DECLARING END TO STATE OF EMERGENCY RELATED TO THE APRIL, 2014 FLOOD – FEMA 4176 AL-DR

WHEREAS, Alabama Governor Robert Bentley on Monday April 28, 2014 declared and confirmed that a State of Emergency existed in the State of Alabama effective as of 7:00 p.m. CST and directed the activation of the Alabama Emergency Operations Plan (EOP) and all appropriate annexes due to severe weather with tornadoes, damaging winds, hail, flooding, and flash flooding; and

WHEREAS, the Town Council of the Town of Perdido Beach concurred with Governor Bentley and the Baldwin County Commission that conditions existed for disaster or for extreme peril to the safety of persons and property within the State of Alabama, including the County of Baldwin and the Town of Perdido Beach; and

WHEREAS, damage occurred on public and private property in the Town of Perdido Beach; and to essential infrastructure of the Town; and

WHEREAS, by reason of the magnitude of damages and disruption, the Town of Perdido Beach was included in the nationally declared disaster under FEMA 4176 AL-DR; and

WHEREAS, all work under FEMA 4176 AL-DR is hereby complete and all projects are closed.

THEREFORE, the State of Emergency is hereby lifted by resolution of the Town Council.

NOW THEREFORE, BE IT RESOLVED by the Town Council of the Town of Perdido Beach that the Ad Hoc Committee is created to serve in an advisory capacity only and that Mayor Parker is hereby authorized to appoint no more than (5) voting members to said committee, one of which will be a council member.
