#### Budget and Finance Meeting Report Town Council Meeting December 14, 2017

- The Committee is continuing to review the various financial reports to ensure expenditures are in line with the budget. Income and expenses seem to be in line for the month of November.
  - The General Fund had roughly \$118,000 in it as of 12/12/2017. This number is like your checking account and varies daily. The income for the first 2 months of this fiscal year is around \$17,000 with expenses excluding paving about \$19,000. This is close enough to be acceptable due to the way income is received. Most paving expenses have been paid with a final total being available next month.
  - The special BP account has \$118,465.94 left in it which represents the money remaining to be spent on the State Street project. The special BP checking account has \$229106.64 remaining in it. Once the storage building project is paid, between 5 and 6 thousand dollars will be left in it.
  - The committee is reviewing the Clerks Salary and Workers Comp insurance for this fiscal year and will make a recommendation in the form of a resolution at the January workshop regarding salary. The committee will also present a resolution requesting the council to approve a town credit card for incidental expenses.
