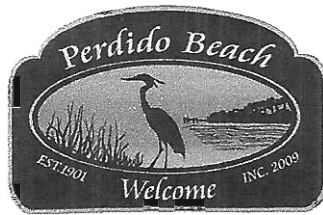

ORDINANCE 2018-06 ESTABLISHING A PARK AT STATE STREET IN THE TOWN OF
PERDIDO BEACH, ALABAMA.

WHEREAS, Title 11, Section 11-47-19, Code of Alabama 1975 provides for the improvement of public grounds, parks, etc. for the establishment and maintenance of parks and recreational property for the enjoyment of the citizens of Perdido Beach; and

WHEREAS, the Town of Perdido Beach desires to establish a park for its citizens to enjoy; and


WHEREAS, establishing a park is consistent with the Town's Master Plan and adds great value to the quality of life for the people of Perdido Beach; and

WHEREAS, it is the desire of the Town Council to preserve the below described property from possible acquisition for other than park purposes;


NOW THEREFORE BE IT ORDAINED that lots 1, 2, 3 and 4, Block 14, Repartition of Blocks 14 and 15 in Soldier's Creek addition to Perdido Beach, according to map or plat thereof recorded in the Office of the Judge of Probate of Baldwin County, Alabama in Map Book 3, page 93, as it is described herein and as depicted on the attached subdivision map recorded at Map Book Number 232 Page 75 in the Probate Court of Baldwin County be and is hereby dedicated for use as a public park and that such park shall not be alienated or sold unless such alienation is first approved through a referendum election as provided in Alabama Code 1975, §35-4-410.

NOW THEREFORE BE IT FURTHER ORDAINED BY THE TOWN COUNCIL of the Town of Perdido Beach, Alabama, that the above described property is hereby approved to be known as **STATE STREET PARK**.
