Mayor's Report:

Mayor Parker shared an email from Griffin Powell-Orange Beach Planning Dept. with the Planning Commission Members-stating that the Orange Beach Planning Commission had passed Resolution 2012-01 supporting the Extraterritorial Planning Jurisdiction boundary with the Town of Elberta and the Town of Perdido Beach in the area east of Wolf Bay, north of Bay La Launch and Arnica Bay and west of Perdido Bay. The Resolution and the map showing the proposed boundary line are attached.

Chairman's Report:

Chairman Love reported that he had presented the "Red Clay Ordinance" to the Town Council as he had been instructed by the Commission. After discussion between the Environmental Advisory Committee and the Town Council, it was the consensus of the Environmental Advisory Committee and the Town Council that placing a one year moratorium on the use of clay in the Town's limits was a better approach to limiting the use of clay and that the moratorium would give the Town sufficient time to create an Ordinance addressing the use of clay.

He also reported that the Estuary Protection Plan created by the Environmental Advisory committee would be presented to the Auburn Team who is working on the Comprehensive Plan for the Town.

<u>ITEM</u>: Motion by Mrs. Fleming, second by Mr. Kiefer to have Dr. Gonsoulin, co-creator of the "Estuary Protection Plan" present the plan as an "educational tool" to the public, at the Town Hall Meeting on February 4th.
