Call from Mr. Vince Jackson, Baldwin County Planner and Administration Staff of Perdido Beach Land Use and Zoning:

- (1) Planning Jurisdiction for all municipalities in Baldwin County will come under recently enacted legislation. All PJ's will be renewed or developed under new agreements.
 - a. First Step will be to renew current jurisdictions that will remain unchanged.
