A Special Council Meeting was held on November 24, 2014 at 6:00pm at Town Hall. The council approved Ordinance 2014-05 (an agreement with the Baldwin County Commission to administer the Town of Perdido Beach Land Use and Zoning Ordinance and Subdivision Regulations.

The council also adopted Resolution 2014-17 Entering into and Executing a Contract with Gene's Dozer Service, Inc. to perform necessary repairs to Riggs Street as a result of damage caused by the severe flood event of April 28th and 29th.

We're in the process of executing the contract. After execution, Mr. Fell will have 90 days to complete the work.
