



**RESOLUTION 2024-02**  
**RESOLUTION ADOPTING TRANSPORTATION PLAN PURSUANT TO**  
**THE REBUILD ALABAMA ACT**

**WHEREAS**, the Alabama Legislature adopted Act No. 2019-02 (the Act) known as the Rebuild Alabama Act to levy additional tax on gas; and

**WHEREAS**, the Rebuild Alabama Act provides for an allocation among the municipalities of the state based on the ratio of population of each municipality to the total population of the state a portion of the additional taxes levied under the Act to be used for transportation and infrastructure, improvement, preservation and maintenance; and

**WHEREAS**, the Act provides that the municipal governing body of the Town of Perdido Beach (the "Town") shall adopt an annual Transportation Plan no later than August 31<sup>st</sup> which shall provide a list of projects for which expenditures are intended to be made in the next fiscal year and shall be based upon an estimate of the revenues anticipated from the fund in which the additional revenue is deposited during the next fiscal year; and

**WHEREAS**, the Act further provides that any such funds received from the Rebuild Alabama Act shall be used only for the following:

1. The maintenance, improvement, replacement and construction of roads and bridges
2. Matching funds for federal road or bridge projects
3. Debt repayment for road and bridge projects; or
4. Joint road and bridge projects within one or more municipalities and/or counties; and such other uses as are defined in the Act.

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of Perdido Beach, Alabama, as follows:

1. The Town Council of Perdido Beach hereby passes this Resolution as its Transportation Plan for the fiscal year 2024-2025 beginning October 1, 2024, and



ending September 30, 2025, submitted in compliance with the Rebuild Act, Act No. 2019-02.

2. Pursuant to the Act, the Town anticipates expending funds received pursuant to the Act, in part or in whole, to fund any of the projects listed on the attached list. The list may be updated by the Town on a yearly basis.
3. That the Town Clerk is hereby authorized and instructed to post a copy of this Resolution as its Transportation Plan which must be at all times posted at Town Hall.
4. That the treasurer is hereby authorized and directed to establish a separate fund maintained by the Town for receipt and deposit of funds received pursuant to the Act, the proceeds of which shall be expended solely for the maintenance, improvement, replacement and construction of roads and bridges maintained by the Town and such other uses as are authorized by the Act.
5. That this Resolution shall take effect upon its passage and adoption by the Town Council.
