




ORDINANCE 2017-03 AMENDING ORDINANCE 2017-02 LEVYING A PRIVILEGE OR LICENSE TAX UPON PERSONS, FIRMS OR CORPORATIONS ENGAGED IN THE BUSINESS OF RENTING OR FURNISHING ROOMS, LODGINGS, OR ACCOMMODATIONS TO TRANSIENTS IN THE TOWN OF PERDIDO BEACH, ALABAMA

BE IT ORDAINED BY THE TOWN COUNCIL OF THE **TOWN OF PERDIDO BEACH**, ALABAMA, that Ordinance 2017-02 is amended as follows:


Section 5. Effective Date. This ordinance shall become effective, upon passage and publication as required by law, and shall commence on the first day of July, 2017. The first payment of taxes hereunder shall be due and payable on the twentieth day of August 2017.

Pursuant to the provisions of the Code of Alabama, 1975, Sections 11-51-200 through 11-51-207, this ordinance levies a privilege or license tax upon persons, firms or corporations engaged in the business of renting or furnishing rooms, lodgings, or accommodations to transients in the Town of Perdido Beach, Alabama and provides penalties for the violation of this ordinance.
