SARPC Representative Report: No Report



There will be a Public Hearing August 1, 2018 at The Al Thompson Community Center to discuss the rezoning of the Town Property.


Public Comment: Chris Head opened up the meeting to public comments at 7:20pm closed at 7:21pm. No one spoke.
